

## Nikkei Online Edition (For Corporate Use) Privacy Policy

This Privacy Policy and [Nikkei Privacy Policy](#) apply to the services of the Nikkei Online Edition (For Corporate use) (hereinafter referred to as "Service").

Nikkei Inc. (hereinafter referred to as "Nikkei") will handle personal information in accordance with this Privacy Policy and [Nikkei Privacy Policy](#). In the event of any inconsistency between this policy and the Nikkei Privacy Policy, the provisions of this policy shall prevail.

### Article 1 Definitions

The following terms used in this Privacy Policy shall have the following meanings:

- [1] License  
"License" means a license to use the Service. One (1) License shall be assigned to each User for each Service.
- [2] Users  
"Users" mean officers, employees and related persons of the customer who use the Service in accordance with the Use Contract of the Service.
- [3] Administrator  
"Administrator" means a person who belongs to the customers and manages the assignment method of the License and utilization status of the Service by Users, etc.
- [4] License Management System  
"License Management System" means a dedicated system to be used by Administrator in managing the License. Only Administrator can use this System.

### Article 2 Acquisition of Personal Information

1. Nikkei will obtain the following personal information under the Service:
  - [1] Names, affiliation, and e-mail addresses of Users, Administrator, person in charge of application for the Service, and person in charge of estimation and inquiry (hereinafter collectively referred to as "Users, Etc.").
  - [2] Other personal information obtained by Nikkei with the consent of the customer and Users, Etc.
2. Users' personal information is provided to Nikkei, when Administrator enters Users' information into License Management System. Users' information should be handled with the consent of Users. Nikkei requests Administrator to obtain the prior consent of Users and enter Users' personal information into License Management System.

### Article 3 Purpose of Use

Nikkei uses personal information for the following limited purposes:

- [1] Guidance of content and functions of the Service;
- [2] Communication and reply for inquiries concerning application, fees, payment, License, termination, and other terms and conditions of use of the Service;
- [3] Request for cooperation for questionnaires, etc.;
- [4] Sending of gift products, gratuity goods, etc.;
- [5] Provision of information on Nikkei's services, advertisement goods, events, etc., other than the Service;
- [6] Other methods for use for which Nikkei obtains the prior consent of the customer and Users, Etc.

### Article 4 Shared Use

1. Nikkei shares personal information of Users, Etc., set forth in Clause 1 of Article 2 with the following joint users:
  - [1] Nikkei America, Inc.
  - [2] Nikkei Europe Ltd.
  - [3] Nikkei China (Hong Kong) Ltd.
  - [4] Nikkei Group Asia Pte Ltd.
2. The methods for use of personal information by the above joint users shall be the same as those set forth in the provisions of the preceding Article.
3. Management of personal information shared among the joint users shall be performed by Nikkei at its responsibility.

### Article 5 Agent

In the case where the customer uses an agent designated by Nikkei in using the Service, Nikkei will provide personal information of Users, Etc., to such agent. The agent shall use such personal information only for the purpose of business to deal with customer with respect to the Service entrusted to the agent by Nikkei.
